J. <u>EDUCATIONAL SHOWCASING OR PRESENTATIONS</u>

(a) **DSBNi – Home Build in Vietnam**

Superintendent Carol Germyn introduced the showcase.

Superintendent Germyn acknowledged the Board's six year partnership with Habitat for Humanity which has provided students with the opportunity to develop construction skills and to learn the importance of connecting with communities and helping others, both locally and globally. The Board's first international build was in El Salvador during the summer of 2009.

Students (Olufisayo Olodade, Sir Winston Churchill; Alexander Mills, Sir Winston Churchill; and Emily DeSilva Piques, Governor Simcoe) from the DSBNi / Habitat for Humanity International summer 2010 build in Vietnam highlighted their experiences and presented a short video. Alexander shared a letter from Prime Minister Stephen Harper commending the District School Board of Niagara and the students for their participation in the Vietnam build. DSBNi ambassador Mitchell Delle Monache presented Director Hoshizaki and Chair Fulford with a framed copy of Prime Minister Harper's letter.

Kevin Johnston presented Director Hoshizaki and Chair Fulford with a print on behalf of the My Tho Vietnamese Front Fatherland Committee in appreciation of the Board's participation in the build.

Emily DeSilva Piques introduced students who were presented with certifications of recognition for their participation in the summer 2010 Vietnam build. Emily thanked the Trustees and Board staff for supporting the project.

Chair Liz Fulford commended the students for their commitment and participation. On behalf of the Board Chair Fulford also expressed appreciation to the staff for their dedication to students and for bringing recognition to the Board.

(b) OMCA (Ontario Mathematics' Coordinators' Association) Award of Excellence

Superintendent Carol Germyn introduced the showcase by stating the OMCA Award of Excellence and Innovation recognizes educators who demonstrate an outstanding contribution to Mathematics education.

DSBN Consultant, Pat Milot, who received the Ontario Mathematics' Coordinators' Association (OMCA) Award of Excellence and Innovation, was recognized for her work on the Supporting Understanding in Mathematics (SUM) program. John Dickson, System Administrator, described Pat Milot as a dedicated and passionate Math Consultant who is well respected locally and provincially for her contributions to Mathematics education.

In recognition of her outstanding accomplishments and contributions to Mathematics education, Director Hoshizaki presented Pat Milot with a certificate of recognition for receiving the OMCA Award of Excellence and Innovation.

On behalf of the Board, Chair Fulford congratulated Pat Milot and thanked her for her dedication and passion on behalf of students.

Pat Milot thanked the Board for its leadership and for supporting provincially recognized programs and initiatives that benefit students.

- Concern was expressed regarding representation on the Committee and an amendment was suggested so that representatives would not be identified by area;
- The Ministry's new parental engagement policy and regulation were reviewed;
- IBM has donated 15 computers through the Education Foundation of Niagara to JK and K programs across the Region;

- The Committee recognized the achievements and contributions of Port Colborne High School teacher Chris Cairns who passed away in August 2010;
- Next meeting is October 6, 2010, at A.K. Wigg Public School.

Chair Fulford added that the Education Foundation of Niagara has received a donation of another computer for a total of 16.

N. QUESTIONS ASKED OF AND BY BOARD MEMBERS

(a) Trustee Gary Atamanyk asked if Trustees can be provided with access to the Niagara Student Transportation Services' (NSTS) secure website to research bus routes and pickup times in order to respond to community concerns. Superintendent Kartasinski replied that the NSTS website is accessible by everyone but information specific to named children is secure for safety reasons.

At Chair Fulford's request, Brenda Stokes Verworn, Board Lawyer, commented on Trustee Atamanyk's request. Brenda Stokes Verworn indicated that Ontario's Information and Privacy Commission has reviewed this issue globally and it has stated that individual student bus routes and pickup times must be secure to ensure the safety of students. Brenda Stokes Verworn reminded Trustees that last year they were asked to forward bussing inquiries to NSTS for a response.

Superintendent Kartasinski added that Trustees can direct their inquiries to her attention and she will forward them to NSTS for a response.

O. <u>NEW BUSINESS</u>

1. ONTARIO PUBLIC SCHOOL BOARDS' ASSOCIATION (OPSBA)

Trustee Don Love noted that the Board's membership fee in OPSBA for 2010-2011 is \$82,434.63 (inclusive of HST). Trustee Love pointed out that the fee is less than the 2009-2010 year due to declining enrolment, and that OPSBA has not increased its budget for the 2010-2011 year. Trustee Love added that OPSBA has outlined the benefits and value of membership in OPSBA.

Trustee Love reported that the Board of Directors will meet in Toronto at the end of September 2010 and that the District School Board of Niagara will host the upcoming Central West Regional meeting.

P. INFORMATION AND PROPOSALS

1. Trustee Information Session

There was no Trustee Information Session.

2. Staff Reports

(a) **Director's Report**

Director Hoshizaki reported the following:

- John Bryant, former Superintendent at Upper Grand DSB, has been appointed Director of the Bluewater District School Board.
- The beautifully renovated facilities at St. Davids Public School were completed and ready for the start of school.
- Board staff met today with community partners in Project Connect to discuss moving the project forward. A report will be brought forward at a future meeting of the Program and Planning Committee. The following community partners are represented in Project Connect.
 - Brock University
 - · Community Care, St. Catharines
 - Niagara College
 - Niagara Region Health Department
 - Niagara Region Community Services
 - YMCA

Chair Fulford reported that a number of Boards have adopted DSBN's successful school year kick off initiative event and Director Hoshizaki was contacted for input following the Board's September 2009 successful event at Brock University.

(b) <u>Verbal Update on Crowland Central Public School Appeal of the Accommodation Review</u>

Superintendent Linda Kartasinski provided a verbal update on the Crowland Central Public School Appeal of the Accommodation Review. Superintendent Kartasinski reported that the Board received a notice of appeal on July 20, 2010, and a written response was submitted to the Ministry of Education on August 4, 2010. Staff are waiting to hear from the Ministry as to whether a facilitator will be appointed to conduct a review. Trustees will be kept informed.

(c) 2010 School Construction Projects Update

Superintendent Jane Roth provided an update on a number of 2010 school construction projects. Superintendent Roth commended Facility Services, particularly Doug Durant and Colin Munro and their staff, for ensuring that projects scheduled for completion for the start of school were ready, including the John Marshall Public School open concept renovations and renovations of E.L. Secondary School's Special Needs rooms. Superintendent Roth noted that construction of the new Crossroads Public School is on target for a September

2011 opening. Superintendent Roth pointed out that although soil conditions at Sir Winston Churchill Secondary School caused a two week delay of the cafeteria addition, construction is well under way and it is expected that construction and upgrades will be completed in 3 phases between March and August 2011. Superintendent Roth noted that a variety of electrical and mechanical projects have been completed, portables have been relocated, and that open concept renovations will continue at a number of schools in 2010-2011.

Doug Durant confirmed for Chair Fulford that eight surplus portables have been sold and there are approximately 45 remaining.

Doug Durant explained for Trustee Love that holes are drilled at every construction site to ensure that the soil is suitable. Sir Winston Churchill was an extraordinary situation in that the soft areas were between the bore holes.

Trustee Gary Atamanyk asked if the construction costs at Sir Winston Churchill are within the approved budget. Doug Durant replied that it is anticipated the contingency allowance provided for in the budget will cover the additional costs related to the bad soil conditions. Costs associated with the soil conditions will be made available when they are received.

Student Trustee James Gillespie added that the construction at Sir Winston is going well.

(d) Verbal Update on Early Learning Numbers

Superintendent Jim Morgan reported that the actual early learning enrolment as of September 13, 2010, is 681 students in 26 classes at the 11 schools participating in early learning. The Board's projected enrolment for September 2010 was 644 students.

Superintendent Carol Germyn reminded the Board that registration for full day early learning is an optional choice and that the Ministry's ELP year one funding is based on 650 students in 25 classes. Each class is staffed by a full time teacher and one Early Childhood Educator. Superintendent Germyn informed the Board that Senator Gibson Public School's actual enrolment of 112 students exceeded the projected enrolment of 88 and it was necessary to add one additional class at that school. Superintendent Germyn commended Superintendents Hyatt and Morgan for ensuring that additional staff was in place for school opening and that the student/staff ratio was resolved. Superintendent Germyn pointed out that the Ministry's guidelines provide for 26 children in every class with a 13-1 student/staff ratio. Most classes in the 11 schools are within the compliance range. Superintendent Germyn also reminded Trustees that the Ministry of Education's guidelines do not provide for an early learning program and a full day kindergarten program in the same school. Superintendent Germyn explained that Director Hoshizaki authorized the addition of the fourth class at

Senator Gibson to provide equity of opportunity for all families at Senator Gibson. The Board will be responsible for the costs associated with adding the fourth class. Enrolment at all 11 sites will be monitored over the next week as part of the elementary staffing process and the Ministry of Education continues to watch the numbers provincially.

Trustee Marcy Heit expressed her concern that enrolment at Westdale Elementary School is too high and she asked what the Ministry of Education's basis was for establishing class size and ratio and how the Ministry will address enrolment that exceeds class size. Superintendent Germyn replied that the Ministry is very aware of the enrolment figures and will continue to monitor areas in the province where the numbers are higher than projected. Superintendent Germyn added that the Board has kept the Ministry of Education informed of its enrolment numbers, including at Westdale Elementary School.

Trustee Heit added that the enrolment at Westdale Elementary School presents a safety issue for students and that the problem cannot be addressed by only making additional classroom space available to accommodate the students. Trustee Heit indicated that she is not prepared to put the safety of children at risk due to the student/staff ratio resulting from the larger enrolment and she suggested that the Board has the option of increasing Board funding to establish and staff another class or withdraw the program. Trustee Heit acknowledged the importance of early learning opportunities and the Ministry's role in providing sufficient funding. Trustee Heit expressed her support for allocating Board funding to staff another class at Westdale Elementary School.

Trustee Clark agreed that the supervision and safety issues due to increased enrolment are a concern and that the Board is responsible for addressing those concerns. Trustee Clark agreed that the Board should alleviate the problem at Westdale Elementary School by allocating funds to assign additional staff. Trustee Clark also agreed that the Ministry has a responsibility to review its funding of the early learning program.

Trustees agreed that the safety issues at Westdale should be addressed. A discussion followed on whether a proposed motion should allow staff the flexibility to establish another early learning program or another full day kindergarten class at Westdale Elementary School. Staffing options were also discussed. Trustees were reminded that the Ministry directs that an early learning program and a kindergarten class cannot be operated at the same school. Trustees were also reminded that the Ministry's current ELP funding for the Board is for 650 students in 25 classes and that there are also other schools with class sizes close to 30. Superintendent Morgan responded to a request for the costs associated with assigning additional staff by stating the cost for a teacher is approximately \$85,000 and the cost for an Early Childhood Educator is approximately \$40,000.

Verbal Update on Early Learning Numbers

Director Hoshizaki pointed out there are other sites with class enrolment of 28/29 students. Director Hoshizaki asked for clarification if the Board is suggesting that only the Westdale situation be addressed at this time. Trustees replied that the Westdale situation makes an excellent case to address the staffing ratio and funding levels with the Ministry.

Moved by Dalton Clark Seconded by Lora Campbell

"That staff be directed to establish another Early Learning Program class at Westdale Elementary School to address the current enrolment issue in the school's ELP program."

Trustee Lemelin noted that it was reported the Director made a final decision on the Senator Gibson situation. Trustee Lemelin reminded Trustees that the Board has final decision making authority and prior to making final decisions the Director should be encouraged to inform Trustees and give them the opportunity to provide input. Chair Fulford commended the Director for taking the initiative to address the Senator Gibson situation in a timely manner.

Superintendent Hyatt confirmed that the fourth class at Senator Gibson is open and operating. Superintendent Hyatt commended staff in Area 3 for their prompt action in responding and ensuring that the class was ready for the start of school.

Superintendent Germyn confirmed for Chair Fulford that a supply Early Childhood Educator has not been assigned to Senator Gibson Public School, however, there are 11 ECE's on the supply list and the staffing issue will be addressed shortly.

Superintendent Morgan confirmed for Trustee Heit that staffing options for the additional class at Westdale Elementary School will be discussed to ensure that staff are assigned as quickly as possible. Director Hoshizaki added that parents will be contacted and staff will be assigned within days. The Communications Department will assist in drafting correspondence to parents. Chair Fulford commended staff for their work in addressing this situation and she asked that Trustees be kept informed.

3. Trustee Communications

(a) Trustee Barb Ness asked that the Student Trustees be provided with silver DSBN pins.

4. Correspondence and Communications

- (c) Request from CUPE Local 4156 to endorse a day of recognition and celebrate the work of Early Childhood Educators and Child Care Staff in our communities.
