# F. EDUCATIONAL SHOWCASING OR PRESENTATIONS

# 1. Director's Report and Recognition

# (a) Principal Jim Heywood, Grimsby Secondary School

Director Hoshizaki recognized Jim Heywood, Principal, Grimsby Secondary School, for his 32 years of service with the Board in a variety of paraprofessional, teaching and Administrative roles. Director Hoshizaki noted that Principal Heywood has exemplified the role of Principal within the Board and he is described as being a great ambassador for all of our schools, and a supporter of the successes of his students, teachers, and staff. Principal Heywood is respected by his peers and Board staff, and he is known for his great sense of humour, positive attitude, and enthusiasm that inspires students and staff.

Principal Heywood is also known for being a system thinker and a system supporter who possesses a wealth of corporate knowledge. Director Hoshizaki added that Principal Heywood is a life-long learner who is willing and open to accept new ideas, and he works hard to implement the change that has made a significant difference to our schools and our system.

## (b) Sheila Welsh, Principal, Edith Cavell Public School

Director Hoshizaki recognized Principal Welsh for exemplifying what it means to be a life-long learner and to never give up on your dreams when, as an adult, she decided to change careers and successfully became a teacher. When Principal Welsh was interviewed by the Board in 1998 she passionately expressed her desire to support special education students and soon thereafter she was placed at Richmond St. Public School, teaching a special education class. Principal Welsh has been the Principal at Edith Cavell Public School since 2007 where she is respected for her no-nonsense, "tell it like it is approach" and good old Principal Welsh leads by example and she fashion common sense. supports her students and families in a variety of ways, both during and outside the school day. Principal Welsh is known for doing whatever it takes to support her kids by breaking through barriers with an iron will that serves notice to everyone - my students will succeed -either come along and support us or get out of the way. Principal Welsh is also known for making everyone feel special and important and for her empathy, positive attitude, and great sense of humour that have transformed Edith Cavell and inspired others to take action.

Director Hoshizaki presented Principals Heywood and Welsh with a token of the Board's appreciation for their service to students.

## (c) <u>Keely Martin – Grade 1/2 Teacher, and Gera Harvie – Educational</u> <u>Assistant, Greendale Public School</u>

Director Hoshizaki recognized Keely Martin and Gera Harvie for teaching and supporting a very unique Grades 1 /2 all boys class with a myriad of needs. Keely and Gera have become an unstoppable team. Their energy, ability to celebrate the strengths in every student and sheer determination have resulted in a class of students who have made huge gains academically, socially and as a community. This class of boys truly are a team who care about and for each other. There have been many challenges, but Keely and Gera have faced them head on as they work to ensure that each boy in this class has reached their full potential.

# (d) French Contest Winner

Director Hoshizaki acknowledged Claire Henderson, a grade 9 Extended French student at A. N. Myer, as the winner of the short story for French "Encounters with Canada" 2012 Fiction Contest. Students are asked to create their own original work in French on a theme they find most inspiring. The contest is open to all Ontario students in grades 9-11 studying French as a Second Language (Core French, Extended French or French Immersion). "Encounters with Canada" is a program of the Historica Foundation of Canada that allows French and English youth from across the country to come together and live a week of unforgettable memories at the Terry Fox Canadian Youth Centre in Ottawa. Claire will be attending the week-long "Encounters with Canada" program in Ottawa next year as her prize.

# (e) <u>Celebrating Leadership in Environmental Initiatives</u>

Director Hoshizaki acknowledged Sharon Keller, Science Program lead at E. L. Crossley Secondary School, who was selected as the winner in the *Volunteer Award* category for the 2012 Niagara Region Environmental Awards Program. Sharon will be recognized at an official ceremony for making a significant contribution to safeguarding our natural environment. As the school leader for environmental initiatives, Sharon formed the "EARTH" club (Environmental Advocates Ready to Help) many years ago. She went on to coordinate fun, educational and memorable activities school-wide and within the community including Energy Audits, Waste Audits, School Ground Greening projects, Water initiatives and more. She has secured funding to support E.L. Crossley's environmental initiatives, including the coveted Toyota Evergreen Learning Ground Program.

On behalf of the Board, Chair Maves commended all of the staff and students on their achievements.

## 2. Grimsby Secondary School - Youth and Philanthropy

Superintendent John Stainsby introduced the presentation which showcased the students' Youth and Philanthropy initiative. Superintendent Stainsby explained that this initiative provides secondary school students with a hands-on experience through a strong academic philanthropy program which gives them the skills to assess community needs and make grants to grassroots charitable organizations meeting those needs. The program empowers young people to actively participate in the development of their communities and engage as dedicated problem solvers and volunteers. The program which is incorporated into the curriculum of participating secondary schools, also promotes a sense of responsibility, respect and a commitment to building compassionate communities.

Superintendent Stainsby will share the benefits of this program with other DSBN secondary schools.

The participating students were presented with a certificate in recognition of their award winning video which showcased the Grimsby Life Centre, a non-profit charitable organization.

## 3. Greendale Public School

Superintendent Cam Hathaway introduced the presentation which featured students from Greendale Public School showcasing their "hip hop moves!"

Principal VandenBeukel explained the history of the program. A performance of the boys showcasing their dancing program followed.

Chair Maves, Vice-Chair Robinson, and Director Hoshizaki presented the students with a certificate in recognition of their achievement.

# 1. <u>Staff Reports</u>

(a) Report of the "Naming the New Welland School" Committee

Moved by Sue Barnett Seconded by Dalton Clark

"That the new elementary school in Welland be named, "Diamond Trail Public School."

# **CARRIED**

Superintendent Wes Hahn outlined the process that was followed by the Naming Committee to recommend a name for the new Welland school in accordance with Board Policy A-9: Naming/Renaming of Schools. Superintendent Hahn acknowledged the community members of the Naming Committee and thanked them for their time and effort throughout the process.

Superintendent Hahn presented three names proposed by the Naming Committee (specifically Diamond Trail Public School, Trillium South Public School, and Southworth Public School), the Policy Criteria that guided the Naming Committee's discussions and the development of proposed names, and the significance of each proposed name to the school community.

Brenda Stokes Verworn, Board Lawyer, explained the balloting procedure as set out in Policy A-9 and noted that she and Superintendent Weinberg will act as Scrutineers.

#### Report of the "Naming the New Welland School" Committee

Trustee Barnett acknowledged all of the members of the Naming Committee for participating in the process, as well as everyone who submitted proposed names.

Following a balloted vote of the three proposed names, Chair Maves reported that the Trustees unanimously selected the name "*Diamond Trail Public School*" for the new Welland school.

- b. That St. Catharines Collegiate Institute and Vocational School be renovated to include an additional science lab and additional technology facilities;

# 2. That West Park Secondary School be closed for instructional purposes as of August 31, 2013, and

- a. That students from West Park Secondary School catchment area be redirected to Sir Winston Churchill Secondary School, effective September 2013;
- b. That for the purposes of technological studies, students within the current West Park Secondary School catchment area have St. Catharines Collegiate Institute and Vocational School as their home boundary school effective September 2013;

# 4. That the Secondary Extended French (French Immersion) Program be split into two locations; and

- a. That grade 9 students north of the QEW and located in Sections S17, S18, S19, S20, S21, S22 and S23 attend Extended French (French Immersion) at Governor Simcoe Secondary School effective September 2013 and the program continue to phase in each year to be a grade 9-12 program in 2016;
- b. That students south of the QEW (excluding Sections S17, S18, S19, S20, S21, S22 and S23) within the current (2011) Sir Winston Churchill Secondary School Extended French (French Immersion) catchment area be directed to attend Sir Winston Churchill Secondary School for the purposes of the Extended French (French Immersion) Program.

## Deliberations on the Central and South St. Catharines and Thorold Secondary Schools Accommodation Review

Superintendent Marilyn Hyatt reminded the Board that in May 2011 the Trustees directed the Senior Staff to begin Phase 1 of the Facility Planning Report by initiating Accommodation Reviews in Fort Erie and Central and South St. Catharines and Thorold. Superintendent Hyatt noted that the purpose of the Accommodation Reviews was to ensure that our Board continues to provide students with the best possible public education experience within the existing economic and demographic realities, and projected declining enrolment. Superintendent Hyatt summarized the Ministry mandated guidelines and Board Policy that were followed throughout the Accommodation Review process. Superintendent Hyatt acknowledged the dedication of the Accommodation Review Committee members and those who have taken the time to offer their comments and constructive feedback during this process.

Chair Maves provided each Trustee with an opportunity to speak to the recommended motion. The Trustees each expressed their position on the recommended motion and also provided their rationale and reasons in support of their position.

In response to Trustee Ness' question on whether or not the recommended motion can be split to allow a separate vote on the Kernahan Park Secondary School motion, Brenda Stokes Verworn, Board Lawyer, explained that under the Board's Rules of Order (Rule 32) a Trustee can ask to split a motion if they claim it contains two or more distinct propositions, and the motions can then be voted upon separately. No seconder is required to the request to split and there is no debate. The vote is a simple majority.

Trustee Bradnam requested a recorded vote.

Chair Maves called the question, all those in favour of the motion.
