**F. EDUCATIONAL SHOWCASING OR PRESENTATIONS****1. Director’s Report****(a) Director’s Recognition for Extraordinary Contributions – Sheryl Pett**

Director Hoshizaki recognized Sheryl Pett for her extraordinary contributions to the Board. Sheryl is responsible for the day-to-day operations of the DSBN Professional Library and she has proven herself to be an essential support for the entire system. She is responsible for keeping all the resources in the collection up-to-date and for informing staff of the latest offerings. Sheryl writes the Professionally Speaking and @Media newsletters, providing ideas for solid resources to support learning. In addition, Sheryl is responsible for creating the records for items that appear in Medianet that allow all staff to find just the right resource for their classrooms. Sheryl goes about her work quietly and efficiently, always willing to help out, and is able to find research on even the most obscure of topics.

Director Hoshizaki and Superintendent Greer presented Sheryl with a token of the Board’s appreciation of her dedication to the Board.

**(b) RCT Volunteer of the Year – Dino Miele**

Director Hoshizaki commended Dino Miele, Chief Information Officer, for being recognized at a recent *Volunteer of the Year* event hosted by Telus in Toronto. Renewable Computer Technology (RCT) is a not-for-profit organization that relies heavily on volunteers to support its mission. Their recognition is given annually to an individual who selflessly donates time and expertise to further the reuse of technology and skill development. Without Dino’s support, thousands of youth, learners and educators across Niagara would not have had access to renewed

technology and enhanced skill development opportunities to further their professional goals and aspirations. Dino has been instrumental in supporting the Computers in Schools and RCTech Outreach Program to provide DSBN students and staff with the tools they need to succeed in the knowledge-based economy.

**(c) Woodend - Walker Industries/DSBN Volunteers Paint Woodend**

Director Hoshizaki recognized employees of Walker Industries and the District School Board of Niagara who recently volunteered their time clearing out the gardens surrounding the Thomson House at Woodend and painting the ceiling, molding and walls of the main meeting room. Director Hoshizaki commended Walker Industries and the Walker employees for their ongoing support of the Living Campus at Woodend.

**(d) Laura Secord Secondary School**

Director Hoshizaki recognized Visual Arts students from Laura Secord who recently painted winter scenes on windows at the St. Catharines Public Library. The students were commended for their tremendous talent and for enhancing the neighbourhood with their excellent work.

**(e) Special Needs Olympics**

Director Hoshizaki reported that six students who participated in the DSBN Special Needs Olympics in June 2012 have qualified to attend the Provincial Special Olympics Summer Games which will be held in York Region from July 11-14, 2013. Director Hoshizaki thanked Andy Dermatas and the DSBN Committee for providing this opportunity for our students.

**(f) November is Movember!**

Director Hoshizaki noted that in Canada, November is "Movember" - a campaign to raise awareness for testicular cancer. Many schools across the Board are engaged in Movember again this year by growing moustaches to show support and also to raise funds for research. Director Hoshizaki commended all of the participants for their tremendous efforts.

Director Hoshizaki reported on the STAT Conference (Students Taking Action Today) which was held recently at Welland Centennial Secondary School. The Conference featured a keynote address and performances by Aboriginal dancers and singers which focused on messages of cultural pride and positive change.

**(h) E.L. Crossley Secondary School Music Video**

Director Hoshizaki reported that E. L. Crossley Secondary School is one of five finalists in the high school division of the eInstruction Classroom Makeover Contest. E.L. Crossley is the only video from Eastern Canada to be in the final round of this international competition. The student written, choreographed, filmed, and edited music video parody could bring home a grand prize package of interactive Science technology valued at \$30,000. **2. Rose Seaton Public School**

Superintendent JoAnna Roberto introduced the showcase. Superintendent Roberto explained that the presentation showcases a classroom initiative involving reading the New York Times bestselling book called “Wonder” and the importance of the class’s initiative entitled “Choosing Kind” in all actions. Principal Cindi Kohinski introduced Rose Seaton Public School Teacher Mallory Milton who spoke about the impact the book had on her class and the whole school community. The Board viewed a video which highlighted the importance of “Choosing Kind” in all actions. Ms. Milton thanked students from Ridgeway Crystal Beach High School for putting the video together.

Director Hoshizaki presented Ms. Milton with a token of the Board’s appreciation for her dedication to students.

**3. DSBN – Brock University Partnership**

Superintendent Sue Greer introduced the showcase which recognized the recent collaboration between the Board, Brock University, and Rodman Hall to support students and provide them with a rich and authentic learning experience in the Visual Arts. Gerda Klassen, Arts Consultant, recognized Teachers Steve Azzopardi, Laura Secord Secondary School, and Larissa Turcotte, Grimsby Secondary School; Dr. Peter Vietgen, Associate Professor for Visual Arts, Faculty of Education, Brock University; Dr. Stuart Reid, Director/Curator of Rodman Hall; and Dr. Jennifer Roswell, Associate Professor, Faculty of Education, Brock University.

Dr. Vietgen addressed the Board and shared details of the research project between Brock University and the Board which provided students with an opportunity to explore the connection between Visual Arts and Literacy. The students were given disposable cameras to create their own images in the vein of Cindy Sherman, a well known American artist, working around the themes of self-identity and role-play. Students also wrote artists statements expressing how they see themselves as teenagers in an ever changing, complex world. This project was a solid affirmation of multi-literacies and demonstrates their significance in our education system today. Dr. Vietgen recognized Rodman Hall for hosting an exhibition of the students' photographs and for facilitating a panel discussion of their work and findings.

Stuart Reid, Director/Curator, expressed Rodman Hall's pride in participating in this project by hosting the display of the students' work and facilitating the presentation of their artwork to the public. Mr. Reid added that Rodman Hall looks forward to future collaborations with the Board and students.

Teacher Steve Azzopardi commented on the significance of Artist Cindy Sherman's work which reflects her statement that we are all products of what we want to project to the world. Mr. Azzopardi commended Gerda Klassen, Brock University and Rodman Hall for embracing this project which provided students with an opportunity to explore and develop visual, oral and written language skills which demonstrate that Art is a powerful vehicle to communicate an idea.

Director Hoshizaki presented Dr. Vietgen and Stuart Reid with a plaque in recognition of their support of students.

On behalf of the Board, Chair Maves thanked Brock University and Rodman Hall for participating in this project along with DSNB teachers and students. Chair Maves added that the Board looks forward to continued partnerships.

Superintendent Sue Mark presented an overview of the 2011-2012 Annual Operational Report (Board Improvement Plan for Student Achievement) which included highlights of the key successes and outcomes of the year together with reference to several key projects that have gained significant momentum over the course of the past twelve months. Superintendent Mark noted that as required by the Ministry, as of 2011-2012, both the academic and corporate Board plans are now included and reported as one Board document. Superintendent Mark also gave a reminder that this planning process is cyclical in nature whereby the accomplishments, successes and challenges of one year determine and establish next steps for the upcoming year. The Board Improvement planning process is an ongoing and ever evolving refinement of plans based upon system-wide assessment data and ongoing feedback from all Departments in the Board.

Superintendent Mark presented an overview and key highlights of the 2012-2013 Board Improvement Plan for Student Achievement which focuses on improving student learning by building professional capacity through job-embedded strategies and practices, and professional learning that are based on research.

Superintendent Mark noted that the 2012-2013 Board Improvement Plan for Student Achievement capitalizes on our most valuable resource - staff, with the one goal of meeting the needs of students. Superintendent Mark added that the Board's Improvement Plan is being given Provincial recognition due to the success of the Board's Professional Learning Communities.

Superintendent Mark thanked School Support Services staff, in particular, Jen Tye, Fred Louws, Cheryl Mancuso, and Kelly Pisek, the Corporate Services leadership and Managers, and the Communications Department who worked diligently to produce the report. Superintendent Mark commended Superintendents Greer and Hathaway for their role in developing the document, and Director Hoshizaki for his focused dedication to provide the best learning opportunities for all students in the District School Board of Niagara.

- (e) Trustee Robinson reported that material is available in the Trustees' Lounge from a recent conference hosted by the Ontario College of Teachers entitled, *Inspiring Public Confidence in Education*. The conference was well attended with good presentations and messaging for the millennium group of students.
- (f) Trustee Robinson reported that students from E.L. Crossley have submitted an application to the Aviva Community Fund to have a skate park in Pelham named in the honour of student Isaac Riehl – *Riehl Skate Park*. The students' submission has reached the semifinals and everyone
