# 1. <u>Director's Report</u>

# (a) <u>Director's Recognition for Extraordinary Contributions – Diane</u> <u>Chase</u>

Director Hoshizaki recognized Diane Chase, parent and Chair of the Board's Parent Involvement Committee (PIC), for her dedication and hard work and for making exceptional contributions over the past 10 years for parents and families in all of our schools in DSBN. Director Hoshizaki acknowledged Diane for her continued time, energy and leadership efforts with the annual DSBN Parent Involvement Committee Conference, which has grown significantly since 2002 as a result of her involvement. Over 600 parents attended last week's 2012 Conference held at Eden High School. Director Hoshizaki noted that Diane first became involved in School Councils in 1996, and she has continued to be active on School Councils at her children's schools. In 1998 she became a member of the School Council Liaison Committee (the PIC predecessor), is a founding member of the Ontario Parent Involvement Committee and School Council Association, and is a member of the Lake Erie Corridor

# (b) <u>Laura Secord Secondary School Drum Flash Mob at Niagara</u> Regional Council

Director Hoshizaki recognized Laura Secord Secondary School students who recently surprised members of Niagara Regional Council when their Drumline Band was invited to appear at Council for a "flash mob" performance. The Board viewed a video clip of the performance which was well received by Niagara Regional Council.

#### (c) South Lincoln High School Pink Football Game

Director Hoshizaki recognized the South Lincoln High School Football Team (Bears) for wearing pink socks in support of finding a cure for breast cancer during their recent home game against West Park Secondary School. The entire school population also supported the cause by dressing in pink. Over \$1,000 was raised to support breast cancer research. The Board viewed a video clip of the initiative.

Director Hoshizaki noted that many DSBN schools took part in fundraising or Breast Cancer Awareness initiatives throughout October and we are very proud of their efforts and community spirit.

#### (d) Westmount Public School

Director Hoshizaki commended staff and students at Westmount Public School on their recent recognition from Thorold Community Care for collecting over 1400 lbs of food during the recent "Hallowe'en for Hungry" campaign.

#### (e) Random Acts of Kindness

Director Hoshizaki noted that the Board sponsored *Random Act of Kindness Day*, which took place on Friday, November 9, 2012. Random Act of Kindness cards were sent to all schools and administration buildings to encourage each recipient to perform a simple act of kindness for someone, hopefully inspiring that person to pay it forward with a kind act for someone else. Director Hoshizaki added that our schools and students quietly perform many acts of kindness for their local communities across Niagara throughout the year and thanked them for their ongoing kindness and generosity.

#### 2. Student Involvement Funding

Superintendent Sue Greer introduced the showcase. Superintendent Greer explained that this past year, the DSBN received \$46,000 in grants that supported 66 Student Involvement initiatives, 51 elementary and 15 secondary. Students participated in a variety of initiatives which engaged them in character based activities in areas such as leadership development, sports, theatre, environmental and anti-bullying.

Students from Connaught Public School, together with Principal Shelley Fehrman and Teacher Deb Mclean, provided an overview of their Mental Karate initiative. Mental Karate is a character based initiative whereby students work through journaling and reflection to the completion of identified character goals. Students shared their experiences and participation in the initiative. Principal Erin Lotherington, Teacher Tracy Garrett and students from Eastdale Secondary School provided an overview of their theatre production entitled "Rumour Has It." The play which was a joint initiative between the school's Safe School Council and the Drama Club deals with bullying issues and in particular the effects of cyberbullying.

The Board viewed a video clip which highlighted Student Involvement initiatives from a number of schools across the Board.

Trustees commended staff and students for supporting and participating in the excellent Student Involvement initiatives.

Trustee Dalton Clark reported on the meeting of October 29<sup>th</sup> noting that the Committee reviewed the request for the appointment of architects for a number of renovation projects at various schools, including projects at twelve Year 5 Full-Day Early Learning Kindergarten sites, as well as a project updating the Sir Winston Churchill Secondary School Science Labs. Trustee Clark also reported that the Committee discussed a report on the *Video Surveillance and Electronic Access – Phase II* project and subsequently deferred the matter to the November 13<sup>th</sup> meeting in order to receive and review more detailed information on the value added items submitted in the Request for Proposal of the second lowest bid.

Trustee Clark reported on the meeting of November 13<sup>th</sup> noting that the Committee reviewed the supplementary information on the value added items with respect to the bid submitted by Quinn Digital for the *Video Surveillance and Electronic Access – Phase II* project. The bid contained an additional estimated value of \$36,953 through their provision of an additional warranty on equipment previously installed as well as additional training services.

In response to a question from Trustee Fulford, Superintendent Weinberg confirmed that the Ministry of Education has approved funding for all twelve Full-Day Early Learning Kindergarten projects.

More than 600 attendees participated in a number of informative workshops. Trustee Clark added his thanks to everyone involved in presenting a successful conference with very informative workshops.

On behalf of the Board, Chair Maves expressed appreciation to the organizing Committee for all their work.
