### (a) Director's Update to Trustees

# i. 8th Annual Cop Shop Event

Community Care has partnered with Niagara Regional Police Services and the Pen Centre for the 8th annual Cop Shop Event. DSBN students will participate in this nationwide community initiative that provides children a unique opportunity to take part in a Christmas shopping spree while spending time in a positive way with local police officers.

### ii. Fort Erie Secondary School Hosts Grade 8 Students

Fort Erie Secondary School hosted grade 8 students from their feeder schools last week. Students had an exciting day exploring the school, cooking, learning about First Nations, Métis and Inuit programming, and creating their own beach chairs.

### iii. DSBN Monologue Competition
