She has kept DSBN students in mind as she made choices of plays and because of her programming, DSBN students have not only been entertained, but invited to think, discuss, and learn.

The DSBN has Jackie Maxwell to thank for many expressions of partnership which include the DSBN/Shaw Monologue Competition, the Curtain Call Program, Artist in the Classroom, The Shaw SHSM Workshops, and FRAMES Competition.

Jackie Maxwell has supported Shaw/DSBN Arts Nights and has supported DSBN teachers with their semi-annual "Shaw Teachers Day", a day of incredible learning opportunities that many DSBN teachers look forward to and attend.

It is under the leadership of Jackie Maxwell that all of these programs have started and flourished. It is clear that the partnership that has been formed between the DSBN and The Shaw has profoundly enriched the lives and education of the students and staff of the District School Board of Niagara.

Director Hoshizaki presented Jackie Maxwell with a token of the Board's appreciation for her extraordinary contributions to students.

## (b) <u>Recognition of Dheiksha Jayasankar, Student, Power Glen Public</u> <u>School</u>

Director Hoshizaki recognized Dheiksha Jayasankar for being an exceptional role model and outstanding student.

Dheiksha Jayasankar is a grade 6 student who has been an active member of Power Glen's school community by being involved in athletic, academic and philanthropic endeavours. At school, Dheiksha Jayasankar is an incredibly hard working, driven student who enjoys challenges and approaches them with confidence.

Dheiksha Jayasankar has already received several accolades for her outstanding achievements outside of school including being named an Ontario Junior Citizen of the Year in 2016. She was also recently selected as one of 13 youths from across Ontario to be awarded the honour for her community service and personal achievements.

### Recognition of Dheiksha Jayasankar, Student, Power Glen Public School

Dheiksha Jayasankar has had her hair cut for students who need wigs due to cancer, sponsored the education of two girls by asking for donations in lieu of birthday gifts, and volunteered at an orphanage in India.

Dheiksha Jayasankar has also been acknowledged for producing several exemplary science fair projects. Most recently, she won first place in the Canada Blooms Science Fair with a project that studied the effect of fruitbased dyes on the electric potential of solar cells. Over the last few years she has successfully competed in the Niagara Regional Science and Engineering Fair, Canada Wide Virtual Science Fair and the United States Exploravision Science Competition. Dheiksha has twice placed in the top 100 worldwide in the World Education Games sponsored by UNICEF and Microsoft in 2012 and 2015.

Director Hoshizaki presented Dheiksha Jayasankar with a token of the Board's appreciation for her extraordinary achievements.

#### Director's Update to Trustees

#### i. DSBN Tribes Team "Engaging All Learners" in Kuwait

DSBN Tribes trainers recently led a team of Ontario trainers to Al-Bayan Bilingual School in Kuwait City for the largest Tribes Training ever undertaken in one session.

The team trained 250 educators including instructional coaches and administrators from pre-school to Grade 12 in both English and Arabic, proving that the Tribes process translates to every community and every grade level. Trainers also engaged over 100 parents and 30 support staff.

Tribes is a process that begins by teaching students the four agreements of Mutual Respect, Attentive Listening, Right to Participate and Pass, and Appreciations/No Put Downs. The process takes participants on a journey of building inclusion, valuing diversity and working together as a community while teaching the curriculum in a way that is engaging and reaches all learners.

### ii. Teacher Appreciation Night

The Niagara River Lions basketball team hosted a teacher appreciation night on March 31, 2016. Superintendent Wes Hahn kicked off the game with the ceremonial tip-off and the Port Weller Pirates took to the court at half time.

☐ The elementary and secondary boundaries for the Oldfield Estates subdivision be shifted to the east to align with Pender Street and the public walkway within the subdivision as shown on Appendix A

☐ The elementary and secondary boundary to the north of the Oldfield Estates subdivision be shifted to the west, as shown on Appendix A, to include Wilson Crescent and avoid the division of properties on McLeod Road and Wendy Drive into different school districts

☐ The elementary and secondary boundaries in North St. Catharines be aligned by transferring Zone A from Laura Secord SS to Governor Simcoe SS and Zone B and C from Governor Simcoe SS to Laura Secord SS as shown on Appendix B

☐ The elementary and secondary boundaries in West St. Catharines/Lincoln be aligned by transferring Zone A, as shown on Appendix C, from Beamsville District SS to St. Catharines Collegiate/Sir Winston Churchill SS for the English and SSTW programs

☐ That the secondary French Immersion program boundary be defined by establishing Zone A, as shown on Appendix C, as boundaried to Sir Winston Churchill SS
