#### i. Support for iHub

The Economic Development Division for the Niagara Region has provided financial support of The Educational Research and Innovation Hub (iHub) partnership between the District School Board of Niagara and Brock University in the amount of \$5,000 towards this first of its kind initiative.

Also, a new collaboration between the District School Board of Niagara and Innovate Niagara will provide start-up companies working out of the new iHub in St. Catharines with more support in bringing their products to market. Having the support of Innovate Niagara will give companies access to mentorship and resources to move from product development to commercialization. The collaborative atmosphere of the iHub promotes discussion, idea sharing and creativity amongst educators, researchers, graduate students, entrepreneurs and education technology companies.
