Trustee Keddy Scott reported that 15 cases were reviewed at both the February 4th and February 17th meetings and strategies were developed for the students' success. Trustee Keddy Scott added that 119 students have been reengaged in learning to date this school year.

Trustee Helga Campbell asked Trustee Keddy Scott to characterize the nature of the student cases that come forward for review by the Committee. At Trustee Keddy Scott's request, Superintendent McGregor responded by saying that each student's background is unique and diverse, ranging from mental health issues, medical issues, or family situations. Superintendent McGregor added that the Committee works diligently to create individual plans that meet the needs of each student.

Trustee Helga Campbell commended the Committee for individually identifying the students' underlying issues that have impacted on their behaviour and learning and for developing strategies for positive learning opportunities.

Trustee Keddy Scott commended Superintendent McGregor and the Committee members for their commitment to the students.

Trustee Ajandi provided a summary and highlights of the report, which included a presentation by the host school, DSBN Academy, on the programs, supports and opportunities offered to the students of the Academy; a presentation by Superintendent Dickson on the 2014-2015 Board Improvement Plan for Student Achievement (BIPSA); and a debriefing on the 2014 PIC Conference. Trustee Ajandi added that the 2015 PIC Conference is tentatively scheduled for November 4, 2015.

Student Trustee Sharma provided a summary and highlights of the report which included presentations and updates on the Elephant in the Room Mental Health Awareness Campaign, the construction of the new Greater Fort Erie Secondary School, and discussion and updates on issues and events taking place in the schools.

Student Trustee Molkoski added that Julie Hopkin, DSBN Social Worker, gave a presentation on the role of Youth Counsellors and Social Workers. Student Trustee Molkoski noted that he and Student Trustee Sharma will attend the February 26th Board Council Conference, which is hosted by the Ontario Student Trustees' Association, and will bring back new ideas and resources to the Student Trustee Senate.

Trustees Fast and Chase commended the Student Trustees for their dedication to students and the Board.

Student Trustee Molkoski explained for Trustee Helga Campbell that the Dare to Dream Program is focusing on providing funding to support mental health initiatives in schools and communities. Trustee Campbell asked for a report summarizing the variety of projects when the grants are approved. Student Trustee Molkoski added that the Student Trustee Senate communicates through Facebook and there will also be updates on that site on where resources are being allocated.
