

Terms of Employment

- □ Orientation In-Class Sessions run from Tuesday July 1, 2014 to Friday July 4, 2014
- □ The Summer Jobs for Youth program runs for 8 weeks, Monday, June 30th until Friday, August 22, 2014
- Integration In-Class Sessions, Weekly in each site, Dates and Times to be announced during the Orientation In-Class Sessions
- Students must complete a <u>minimum</u> of 6 hours per day, 5 days per week, (minimum 220 hours) plus complete written assignments to achieve 2 credits
- □ To attend **MANDATORY** paid, in-Class Sessions weekly if you are in the Summer Jobs for Youth Program.
- □ To follow all rules, regulations and policies of both the employer and the District School Board of Niagara related to dress, health and safety, attendance and work schedule
- □ To work in an appropriate manner, exhibiting good work ethic, initiative and citizenship
- □ To make the employer aware of any special health issues that might impact on your placement (e.g. medication requirements)
- □ To have your own transportation to and from your Co-op placement and In-class sessions
