a) <u>Director's Update to Trustees</u>

2. Educational Showcases

a) The Great Peace by artist Raymond Skye

Director Hoshizaki introduced Raymond Skye, Iroquois Artist, and spoke to the piece being presented. Director Hoshizaki explained that Raymond Skye's piece, The Great Peace, represents the Haudenosaunee people – the Mohawk, Oneida, Onondaga, Cayuga, and Seneca.

EDUCATIONAL SHOWCASING OR PRESENTATIONS – continued

a) The Great Peace by artist Raymond Skye

Raymond Skye provided an overview of the painting that was inspired by a dream that he had over 20 years ago. At the time he didn't know the significance of what he was creating or why, but during his journey he learned a great deal. The Great Peace represents the five nations of Iroquois, all of which were in a dark and troubled time. Today our world is still troubled, and nations are trying to find and maintain peace. Raymond Skye's hope is that the journey that this artwork is on reaches out to people.

b) Landscape of Nations 360° Memorandum of Understanding

Superintendent Roberto introduced Michele-Elise Burnett, President of Kakeakalanicks, an Indigenous consultancy company which helps educate and promote Indigenous art and artists.

Superintendent Roberto explained that Michele-Elise Burnett will provide highlights of her work with Tim Johnson on the Landscape of Nations 360° initiative and then sign a Memorandum of Understanding with Director Hoshizaki. The Memorandum of Understanding supports the Landscape of Nations 360° Pilot Teacher Training Institute where DSBN educators will continue to explore, design, and gain Indigenous perspectives aligned with the curriculum and framed around the 10 essential understandings of Indigenous Peoples' history in the region.

Michele-Elise Burnett thanked DSBN for their support and spoke to the importance of the partnership and transforming how and what students are taught about Indigenous Peoples and history. With workshops and roundtable discussions we will emerge with a dynamic, authentic, inclusive teaching program.

Michele-Elise Burnett and Director Hoshizaki signed the Memorandum of Understanding Agreement.

Superintendent Courtois advised Trustees that the 2019-2020 staffing process resulted in no lay-offs for any employee group. Factors such as retirements, projected enrolment increases, and reallocation of resources have led to an increased complement of elementary and secondary teaching staff for this school year.

The projected elementary enrolment for the 2019-2020 school year is 25,883 and this year's projected secondary enrolment is 11,898. DSBN was able to provide continuity to secondary programming despite the reduction in secondary funding through the reallocation of central resource staff to classroom teaching positions.

DSBN will continue to ensure all classrooms are staffed appropriately throughout the year.
